#### B & Capital, an independent entity

- **B & Capital** is an independent company, with its own management and solely responsible for its investment decisions. Its investment activities are fully independent from Roland Berger's consulting activities. In this respect, a stringent conflict of interest policy is being implemented at each phase of the investment and monitoring process.
- **B & Capital** will soon file for its registration as portfolio management company by the French financial markets regulator (AMF). The next step will be then to propose a first comingled fund to eligible investors.
